

Agreement made December 22, 1999 between, Jack Dongarra, Ian Foster, Geoffrey Fox, Ken Kennedy, Linda Torczon, and Andrew White, the Editors, and Morgan Kaufmann Publishers, the Publisher.

Preamble

Whereas, the Editors intend to compile and have published an original work, and whereas the Publisher is in the business of publishing such works, the Editors (you) and Publisher (we) agree as follows:

1. Grant of Rights

You agree to prepare for publication a compiled work tentatively entitled *The CRPC Handbook of Parallel Computing*, (the Work) comprising chapters written by others and original material written by yourself, and you grant and assign exclusively to us this Work, its parts and all versions and revisions of the work that are now in existence or created in the future, except for chapters included in the Work that are subject to agreement between the Publisher and others, as described in Paragraph 12. This grant and assignment includes all rights of copyright (and to claim, register, and obtain copyright) in the Work and in all countries of the world, and the exclusive right to print, publish, and sell the Work throughout the world during the full term of copyright, and all of the other rights set forth in Paragraphs 13 and 14 below, with the exclusive authority to exercise or to dispose of these rights in all countries and in all languages. You and we agree that all published copies of the Work shall bear the copyright notice or notices required by applicable law in our name or in any other name or names we elect. To protect this Work or the rights granted to us, we may need to file certain documents with the Copyright Office confirming this grant of rights. If we ask you to sign such documents, you agree to do so.

2. Delivery and Acceptance of Manuscript

You agree to deliver to us a complete manuscript for review comprised of your own material and that produced by contributing authors, consisting of approximately 750 double-spaced manuscript pages, not later than February 14, 2000, and as final manuscript including all figures ready for production not later than April 15, 1999. You agree that these length specifications are important, and that both parties desire a published book of not more than 600 pages, including front and end matter, and include no more than 80 figures and no more than 8 published pages of 4-color art. When we have accepted and approved your final manuscript for production, you will receive notice. We will then publish your book, at our expense, in the United States in the English language. If your final manuscript is not acceptable to us, or if it is not delivered within six months of the date indicated above, and if in our opinion an extension of time is not advisable, we may at any time thereafter and at our option terminate this Agreement by notice in writing mailed to your last known address.

3. Royalties

Except as otherwise provided herein, we will pay you royalties of zero percent (0%) of the net amount received by us from sales (excluding sales taxes and transportation charges) of all copies of the Work sold (less returns) throughout the world. This royalty will apply to all copies of the English language edition of the Work that are sold by us, including those sold directly to consumers, to bookstores and distributors, by mail order, at conferences and all other purchasers other than those stipulated in Paragraphs 13 and 14 below.

4. Reports and Payments

Beginning after publication, the Publisher will render semi-annual statements in accordance with its regular practices, during the month of April for the previous period beginning July 1 and ending December 31, and during October for the previous period beginning January 1 and ending June 30, each year. Each statement will be accompanied by payment of the amount shown to be due, after allowance of a reasonable reserve for returns. All payments to Editors will be divided equally unless another division is specified by you in writing. If less than twenty-five dollars (\$25.00) is due for any accounting period, the Publisher may render no statement and make no payment until after the accounting period in which a total of twenty-five dollars (\$25.00) or more is due the Editors. The Publisher may deduct from amounts due the Editors under this Agreement any sum due from the Editors to the Publisher under this Agreement.

5. Submission and Form of Manuscript

You agree to deliver one (1) copy of the final manuscript to us in a form suitable for copy editing: clean copy, printed double spaced on 8 1/2 x 11 sheets with accompanying LaTeX electronic files. The manuscript will include contributed chapters selected by you, introductory or other original material which you create, and any other references, titles, or bibliographic information that you and we agree are required for final publication.

6. Artwork

You agree to require contributing authors to provide eps files for all black-and-white artwork. You agree to require contributing authors submitting 4-color art to submit digitized art files. Correct placement of the art will be indicated by figure number in the accompanying text manuscript. In turn, we shall prepare the art for final publication.

7. Editing, Typesetting, and Indexing

When your final manuscript has been accepted and approved for production we will copy edit the Work, provided that such editing or alteration does not materially change the meaning of the Work. We shall then return the copy edited manuscript to the authors and to you for approvals, and you agree to return it to us in a timely manner.

We agree to then typeset the Work, and submit proof to you for examination. You agree to read, correct and promptly return proof to us and agree to be responsible for the completeness and accuracy of your corrections. If your failure to detect errors in the proofing stage results in a published text that contains an excessive number of errors, thereby limiting the sale or the potential sale of the text, the costs of making these corrections in a subsequent printing will be charged against your royalties. Unless we agree otherwise, should the costs of alterations that you or the contributing authors make to the text and illustrations after typesetting exceed 15% of the costs of original typesetting, this amount will be charged against your royalties. These charges will not include your corrections of typesetting or editing errors but only alterations you make after you have approved the final edited manuscript or electronic files and final illustrations. We will hire a professional indexer to prepare an index for the Work.

8. Cover

Based on discussions with you we will prepare a design for the cover of the book. You agree to provide us with an approximately 100-word description of the Work which we may use as the basis for preparing a promotional statement for the cover or jacket. You and we shall share approval over the final cover of the book and the promotional statement.

9. Determinations

We agree to consult with you on publication and marketing matters. You and we shall share approval over the title of the published Work. We shall retain sole right to establish the price of the book and to determine all other publishing and printing details, including, but not limited to, selection of paper and number of copies to be printed. In the event that co-editors are unable or unwilling to reach agreement suitable for approval, our determinations will be final. We agree that the following individuals will be credited as editors of the Work: Jack Dongarra, Ian Foster, Geoffrey Fox, Ken Kennedy, Linda Torczon, and Andrew White

10. Editor Copies

We agree to provide each Editor with five (5) free copies of the finished Work and to provide each contributor with four (4) free copies of the finished Work when it is published. You may purchase additional copies of the Work at a 32% discount from the retail price.

11. Revised Editions

If we determine that a revision of the Work is desirable, we will send notice to you and request that you prepare a revision. You agree to advise us within ninety (90) days after notice is sent of your intentions to prepare a revision. You also agree to diligently proceed with the revision, keeping us apprised of your progress, and to deliver the completed manuscript to us with reasonable promptness, but in no more than twelve (12) months from the time you agree to revise.

In the event that you do not advise us within ninety (90) days, are unwilling or unable to proceed with the revision, or if the completed manuscript that is acceptable to us in form and content is not delivered within six (6) months of the date agreed upon for submission, or if you have died or become disabled; we, in consultation with any of you who are available, willing, and able to proceed with the revision, will have the right to arrange for the revision to be prepared by others. We will also arrange for the reviser to share royalties with you, provided the reviser's share will not exceed 50% of net royalties in the first revision or 75% of the net royalties in the second revision. The reviser's share of the royalties on subsequent revisions will be negotiated between the Publisher and the reviser. Each of you has the right to withhold your name as co-editor of any future revisions in which you do not participate provided we receive written notice six months prior to publication.

12. Copyrighted Material

You agree to require each contributing author to provide us with proper written grant of the same rights you have granted to us for the entire Work in Paragraph 1, under the terms of a Copyright Transfer Agreement substantially in the form attached hereto as Attachment A. If any material from another work protected by copyright is incorporated into your manuscript or the manuscripts of the contributing authors, we must receive written grants satisfactory to us to use that material. We agree to seek to obtain rights that must be granted to us, and you agree to assist us in obtaining these rights. If a fee is charged by the copyright owner for such rights, we will advance such payment and deduct the amount from your future royalties.

13. Subsidiary Rights

The rights you have granted us include but are not limited to the following exclusive subsidiary rights in and to the Work, which we may exercise, license, assign, or otherwise dispose of, in all languages, forms, and media throughout the world:

- a). To prepare, publish, sell, and distribute translations, sound recordings, microfilms, microfiches, filmstrips, motion pictures, and all other derivative works.
- b). To serialize, syndicate, quote, or authorize quotations and excerpts (including illustrations), and to authorize the use of your name in connection therewith.
- c). All performance, broadcast and display rights, and all rights for use in information storage, processing, transmission, and retrieval systems.

The term "Subsidiary Rights" shall mean the subsidiary rights listed above and all other rights in the Work that you have granted to us, except the rights granted to us to publish and sell the English language version of the Work in book form. The royalties or other income we pay to you from the exercise or disposition of such subsidiary rights are set forth in Paragraph 14 below.

14. Royalties on Subsidiary Rights

You will share equally with us any net gain after direct expenses received by us on any disposition to others of a particular subsidiary right, such as translation rights or any disposition to others of English language book club rights, or rights to print special English language reprint versions and adaptations that are intended primarily for sale outside of the United States, its possessions, and Canada. You will receive royalties of 10% of the amounts received by us on resulting sales if we develop ourselves and exercise a particular subsidiary right or join with others in such development or exercise.

15. Editors' Warranties

You warrant that you are the sole owners of this compilation and are the author and proprietor of your contributions to this Work and have full power to make this Agreement and the grant and assignment set forth herein, (except as provided for in Paragraph 12 above) and have not previously granted, assigned, or encumbered any of the rights granted and assigned hereunder; that the compilation and all material you create for the initial edition of the Work and all new material for subsequent revision thereof (except previously published material for which permissions are obtained as described in Paragraph 12) is and will be original, unpublished, and not previously the subject of an application for copyright registration; that it does not contain any matter libelous or otherwise unlawful; that it contains no instruction that may cause harm or injury; and that it does not infringe, violate, or invade any copyright, right of privacy, or other proprietary or personal right, all whether statutory or nonstatutory.

You agree to indemnify and hold harmless the Publisher, its assignees, licensees, and purchasers, and the officers, employees, and agents of all of them, from all costs, expenses (including reasonable attorneys' fees), losses, liabilities, damages, and settlements resulting from any breach of the foregoing warranties and agreements. In the event of a claim or suit of such a breach we may withhold payments due to you hereunder and we will notify you of such claim or suit within thirty (30) days of our legal receipt of such notification. The warranties and agreements contained in this Paragraph 15 shall survive the termination of the Agreement.

We agree to publish the following statements on the copyright page of the book: "The programs, procedures, algorithms, and applications presented in this book have been included for their instructional

value. The publisher and the authors and the editors offer NO WARRANTY OF FITNESS OR MERCHANTABILITY FOR ANY PARTICULAR PURPOSE and do not accept any liability with respect to these programs, procedures, algorithms and applications.”

16. Accounting

You agree that any overpayment of royalty due to returns of stock from bookstores and dealers, and amounts of any nature that you may owe us under this Agreement, shall be retained for our own account from the royalties otherwise due you from this Agreement between us. For purposes of computing royalties under or pursuant to this Agreement, all assignments by us of this Agreement as a whole and any transfer of inventory to the assignee in connection therewith shall be disregarded. You shall have the right, after due notice to us, to examine, at your own expense, our records showing the number of sales of the Work or rights relating thereto and the revenue received from such sales.

17. Reversion of Rights

In the event that we, at our sole discretion, decide that it is no longer in our best interest to continue to sell or market the Work, we will notify you by registered mail at the address last given by you. We will then offer to grant back to you all rights granted under this Agreement, subject to all rights which may have been granted by the Publisher to third parties. We may also offer to sell you remaining inventory and film for the Work in the event that it is taken out of print.

18. Changes, Assignments, Waivers

This Agreement may not be changed unless you and we agree to the change by means of a formal addendum signed by you and an officer of our firm. You may assign your royalties for the Work but you may not assign this Agreement. We, as the Publisher, may make an assignment of this Agreement to any of our affiliates or subsidiaries or as part of a transfer of all or any material part of our publishing business.

19. Interpretation

This Agreement shall be construed and interpreted according to the laws of the State of California and shall be binding upon the parties hereto, their heirs, successors, assigns, and personal representatives; and references to you and us shall include your heirs, successors, assigns, and personal representatives and ours, subject to the restrictions on assignments stated in Paragraph 18. Whereas the Editor consists of more than one person, all of the Editor's obligations shall be deemed to be joint and several obligations of those persons.

20. Editors' Liability

Except for the indemnity obligation under Paragraph 15, the Editors' will have no liability to the Publisher beyond the royalty amount payable to the Editors under this Agreement.
